RESOLUTION 2025-01-S

Mercersburg Sewer Authority Rates & Fee Schedule

WHEREAS, the Mercersburg Sewer Authority, Franklin County Pennsylvania has found it economically necessary to implement charges for various services and set fines for various ordinances; and

WHEREAS, The Mercersburg Sewer Authority hereby establishes the following schedule of fees for the administration and processing of applications for service, Base Consumer Fees, Usage Fees, Work Costs, Meter Testing fees, equipment rentals, technical services, fines and various other administrative fees, and

WHEREAS, all fees, newly established or amended, are effective on October 1, 2025 and supersede all fees enacted prior to this date, and

NOW THEREFORE BE IT RESOLVED, by the Mercersburg Sewer Authority of the Borough of Mercersburg, Franklin County, Pennsylvania, that the Authority does hereby adopt the following schedule of fees.

Invoices are due in full 30 days from receipt. A delinquency charge of 1 1/2% per month will be assessed on accounts that are not paid within the 30-day time-period.

All professional services are billed at actual costs (legal, engineering, etc.) – see professional fee schedules.

Tap-In Fee \$4,801.19

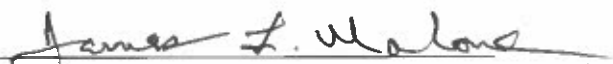
Where any building connected to the sewer system is to be converted or enlarged such that the sewer service usage is greater, or additional buildings are to be constructed on a property and connected directly through a new line, the owner of the property so improved shall pay an additional tap-in fee for each such conversion, enlargement, or connection. Indirect connections through an existing line shall not be permitted. Credit will be provided for any prior payment made for smaller lines or lesser EDUs

Reconnection Fee	\$50.00

Surcharge Fee Calculation
for B.O.D. and T.S.S.

The Meter Rate Charge shall be increased by five one hundredths of one percent (5/100 of 1%) for each part per million which the average suspended solids of the waste or sewage exceeds 300 parts per million plus five one hundredths of one percent (5/100 of 1%) for each part per million by which the average five (5) day biochemical oxygen demand (B.O.D.) exceeds 300 parts per million.
